
**10. CHIEF REPORT**

Chief Wilson reported that the July Ops report is in the packet. There were a few sizeable bursh fires in the Black Canyon area. Thanks to 310 Dust control, we have been able to maintain a water site at sunset point and have used it quite a bit.
- b. American Heart Association Mission Lifeline Gold Award  
Chief Jarrett reported that we have received this award for the 4<sup>th</sup> year in a row and last year we were the only Arizona organization to receive the additional cardiac award. He went over the criteria we must meet to achieve this award and how important the partnership with our hospital is.
